On the third Tuesday of every month, Neighbors In Need distributes food at Calvary Chapel to over 300 households in Dallas County. This institution is an equal opportunity provider.

How to Qualify

Food Distribution is a needs-based program. Qualifications are based on household size and income. Only one distribution per physical address is allowed.

To begin receiving food, please bring the following documents to your first distribution:

- 1). **Valid Photo ID**
- 2). **Proof of Income**
(Pay Stubs, W-2, or proof of already being approved for Government Assistance, such as a EBT Card)
- 3). **Proof of Dallas County Residency**
(Voter Registration Card, Mail with your name and physical address on it.)
